Terms & Conditions

These Terms and Conditions must be read and agreed to before Listees are able to create a Locations Directory entry. Screen Canberra reserves the right to modify these Terms and Conditions at any time.

Eligibility

- The Listee must be a Canberra Australian Resident or Company as defined in the Screen Canberra Terms of Trade and be able to supply proof of residency (physical address). A Post Office Box address or other mailbox address is not sufficient.
- Regular non-resident suppliers to the ACT screen industry may be considered for listing in certain circumstances. Please complete the registration process, ticking the relevant box below and Screen Canberra will review your request.
- The Listee is responsible for all photos and any related content I upload to Screen Canberra's website for the purpose of its location database

Conditions of Use

- By creating an entry, you authorise Screen Canberra to publish the information you provide in the Locations Directory and acknowledge that this Directory is publicly viewable online.
- Listees warrant that the information they provide is true and accurate.
- The Listee grants Screen Canberra a royalty-free, non-exclusive, perpetual, transferable licence (with a right to sub-licence) to use, reproduce and distribute content in any media worldwide for the purpose of Screen Canberra's locations database and general marketing and promotion of ACT locations for film and television production.
- Listees continue to retain copyright and any other rights they hold and understand can continue to share and commercialise Locations Content as they wish.
- Listees confirm that they own and/or have received the necessary permissions to provide the above licence and that they are not infringing any person's rights by submitting content to Screen Canberra's website
- Listees agree that are solely responsible for (and that Screen Canberra has no responsibility to me or to any third party for) any breach of my obligations under the Terms of Use and for the consequences (including any loss or damage which Screen Canberra may suffer) of any such breach.
- Listees warrant that they will not submit any information or material to the Locations Directory that is copyrighted, embargoed or otherwise subject to any third-party proprietary right, unless:
 - a. they are the owner of such rights in the material or have the permission of the rights owner to use the information, and

- b. grant Screen Canberra all necessary licenses to enable them to use such information in the Locations Directory.
- Listees must update their listing as soon as possible if changing business address or residency.
- To maintain a listing in the Screen Canberra Locations Directory, the Listee must log in and view and update their listing every 2 years.
- Screen Canberra reserves the right to archive listings that are not updated annually. Archived listings are not able to be viewed online.

Review Process and Publication

- Screen Canberra reserves the right to contact the Listee regarding Locations Directory issues via the email address they provide.
- To be associated with a business that already has a listing within the directory, Screen Canberra will send a validation request to the administrator of the company listing.
- Screen Canberra reserves the right to remove a listing from the site in the event a listing contains false or misleading information, including individuals who are determined to be non-residents.
- Screen Canberra is entitled to remove any content it deems to be offensive, obscene, unlawful, inappropriate, defamatory, or infringing on the rights (including copyright) of any third party.
- Screen Canberra will correct factual errors that come to our attention, and we welcome all parties to inform us of inaccuracies.

Data Privacy
