



LOCATIONS TRAINEESHIP 2023 GUIDELINES

In partnership with the ACT Government and Screen Australia, Screen Canberra is launching a suite of opportunities to build capacity in the local filmmaking community in a variety of roles.

Location and Unit Management is an underserviced area within the ACT Region and nationally. Successful applicants will develop the skills needed to pursue a role within the locations department, including scouting, assistance and management and unit management.

- A **Location Manager** is responsible for finding and securing all the locations required for filming on a film or television production. They also handle the logistics of filming at each location, obtaining permits and permissions and often serve as the public face of the production in filming areas.
- During pre-production, a location assistant will help with researching locations, organising visits and take
 photographs of the site. In production, they might write letters to residents informing them of the local
 filming.
- With some guidance from the director and producer, the **location scout** finds places to shoot that coincides with the director's concepts and fits in the producer's budget. Scouts will use a combination of physical research and direct communication to find locations that meet the brief.

KEY SKILLS AND ATTRIBUTES:

- Ability to lead
- Excellent communication and interpersonal skills
- Ability to read and listen to briefs and creatively interpret them as per instructions given by head creatives
- Competent photography skills
- Strong attention to detail
- Experience with maps and navigation

- A creative spirit
- Must have a driver's License and reliable vehicle
- Organised
- Must be organised, flexible and reliable
- Calm under pressure
- Strong knowledge of Canberra and its geographical locations

SCOPE OF WORK:

Trainees will be equipped with the skills to undertake any of the roles within the location department, as required by various productions.

This course is due to be held over 2 weekends, on the 28th, 29th of January and 4th of February 2023.
